HSBC Business Mastercard® Incremental Spending Reward Offers

Promotional Terms and Conditions

Eligibility

- 1. This promotion (the "Promotion") only applies to selected companies (each a "Company") and the eligible holder of a Business Mastercard under the same Company account to whom the promotional electronic mailer of this Promotion ("eDM") is specifically addressed to ("Eligible Cardholder(s)"). For the avoidance of doubt, eligible Business Mastercard(s) ("Eligible Business Card(s)") are the designated Business Mastercard(s) as stated on the eDM(s) issued by The Hongkong and Shanghai Banking Corporation Limited ("HSBC" or the "Bank") in the Hong Kong Special Administrative Region ("Hong Kong").
- 2. In addition to these terms and conditions, the terms and conditions in (i) the HSBC Business Card Programme Agreement; and (ii) the HSBC Business Card Rewards Programme will continue to apply.
- 3. Employees of the Bank are not eligible to participate in the Promotion.

RewardCash Offer

- 4. If the aggregate value of Eligible Transaction(s) for RewardCash Offer (as defined in clause 8) effected under an Eligible Business Card between the promotion start date and promotion end date as stated on the eDM (based on transaction date) ("Promotional Period") exceeds the spending target as stated on the eDM (the incremental portion is referred to as "Incremental Spending"), additional RewardCash will be awarded ("RewardCash Offer").
- 5. The RewardCash Offer will be equivalent to 8% of the Incremental Spending amount (rounded up to the nearest integer), subject to a maximum amount of \$1,000 RewardCash for each Eligible Business Card within the Promotional Period.
- 6. Each Eligible Cardholder must successfully complete an online registration via www.business.hsbc.com.hk/cardevergreen with the Eligible Business Card during the Promotional Period ("Registration") to be entitled to the RewardCash Offer. No RewardCash Offer will be awarded to the Eligible Business Card if the Eligible Cardholder fails to register for his/ her Eligible Business Card.
- 7. The Bank will determine the eligibility of the cardholder(s) for the RewardCash Offer based on the transaction records held with the Bank. The completion of Registration does not imply that the RewardCash Offer will be awarded.
- 8. Only posted local and overseas transactions with original sales slips, telephone orders, fax orders, mail orders, online transactions and cash advances effected with an Eligible Business Card with original sales slips/ official payment records are eligible for calculation towards the eligible transactions ("Eligible Transaction(s) for RewardCash Offer"). Other transactions, including without limitation, online bill payments, tax payments, autopay, recurring transactions, instalment plans, all fees and charges, insurance payments, casino transactions, unposted/ cancelled/ refunded transactions and all transactions without original sales slips/ official payment records are not eligible for the RewardCash Offer.
- 9. If an Eligible Transaction for RewardCash Offer is conducted in a currency other than Hong Kong dollars, the transaction amount will be based on the amount in Hong Kong dollars after conversion as posted in the credit card statement.

General Terms & Conditions

- 10. Eligible Cardholder can enjoy the RewardCash Offer with the Eligible Business Card once under the Promotion within the Promotional Period.
- 11. Transactions effected with different Eligible Business Cards under the same Company account shall not be aggregated for the purpose of calculating the maximum amount of reward under the Promotion.
- 12. If the Eligible Transactions for RewardCash Offer are verified and confirmed as qualified by the Bank, the applicable RewardCash will be automatically credited on or before the last calendar day of the 2nd calendar month after the end of the Promotional Period to the Eligible Business Card account as applicable.
- 13. The RewardCash Offer will be awarded in addition to the basic RewardCash under the RewardCash Programme that is offered by the Bank.
- 14. Eligible Cardholders and Companies have to keep all original sales slips or official payment records of the Eligible Transactions for RewardCash Offer. In case of dispute, the Bank may at any time request the Eligible Cardholders and Companies to submit those slips, records, and/or further evidence for inspection and the Bank may keep a copy of them for record.
- 15. Only Eligible Cardholders and Companies whose Eligible Business Card accounts are valid and in good standing from the start of the Promotional Period until the date on which the applicable RewardCash is credited will be eligible for the RewardCash Offer. Any fraud and/ or abuse of the offers will result in forfeiture of the Company's and the Eligible Cardholder's entitlement to the offers. The Bank reserves the right to debit the relevant amount of the RewardCash Offer awarded directly from the Eligible Business Card account without any further notice.
- 16. In case of disputes arising out of the offer under the Promotion, the decision of the Bank shall be final and conclusive.
- 17. The Bank reserves the right to suspend and/ or terminate granting of any RewardCash Offer under the Promotion, and/ or vary these terms and conditions at any time without prior notice. The Bank accepts no liability for any such change or suspension/ termination.
- 18. No person other than the Bank, the Eligible Cardholder and the Company will have any right under the Contracts (Rights of Third Parties) Ordinance to enforce or enjoy the benefit of any of the provisions of these terms and conditions.
- 19. In case of discrepancies between the English and Chinese versions of these terms and conditions, the English version shall prevail.
- 20. These terms and conditions are governed by and construed in accordance with the laws of Hong Kong. Each of the Bank, the Company and the Eligible Cardholder submits to the non-exclusive jurisdiction of the courts of Hong Kong but these terms and conditions may be enforced in the courts of any competent jurisdiction.
